NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING APPROVAL OF TERRITORIAL AGREEMENT

BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On April 1, 1994, Suwannee Valley Electric Cooperative, Inc. (Suwannee) filed a petition to resolve a territorial dispute with Florida Power Corporation (FPC). The dispute was set for a Chapter 120.57 formal hearing, which was later delayed upon approval of a 90-day stay. In the interim, the parties negotiated and on December 13, 1994, filed a Joint Petition for Approval of a Territorial Agreement.

The purpose of the territorial agreement is to identify Florida Power Corporation's (FPC) and Suwannee Valley Electric Cooperative, Inc.'s (Suwannee) respective service areas in portions of Columbia, Lafayette, Madison and Suwannee counties. Composite Exhibit "A" to the agreement is a collection of detailed maps that defines the respective territorial boundaries within the previously mentioned counties. Although important, this exhibit is too voluminous to attach to this Order. Exhibits "B" and "C" are listings of customer accounts that will be subject to transfer upon approval of this agreement. The Territorial Agreement together with Exhibits "B" and "C" are attached to the this Order labeled Composite Exhibit 1.

Exhibit "B" to the agreement identifies a total of 60 Suwannee customer accounts which will be transferred to FPC and 6 FPC customer accounts that will be transferred to Suwannee. Exhibit "C" is a subset of 49 Suwannee customer accounts and 4 FPC customer accounts identified on Exhibit "B" which will be transferred to the respective utility as soon as is reasonably practicable taking into account economics, good engineering practices and the efficient Continued service to these customers operation of the utility. would present operational concerns both utilities want to prevent. The remaining 13 customers will be transferred by Suwannee and FPC upon a "change-in-use" or at such time as a customer requests to be transferred. From time to time, each utility may also advise the affected customers of their option to request a transfer to the appropriate utility. In any event, Section 2.7 of the agreement provides that all customer accounts transfers shall be completed within five years from the date of Commission approval. Once the transfer period has passed, neither utility will be serving customers outside its respective service area.

All affected customers were notified by letter of the proposed transfer and advised of the difference in rates. This notice included a rate comparison for both residential and commercial customers for varying monthly KWH usages. Of the customers responding 4 were in favor of the transfer and 2 opposed. It appears that customer disapproval was based solely on rates and not on an anticipation of a decrease in the quality of service.

Section 2.2 of the agreement states that neither utility will knowingly serve or attempt to serve any customer whose end-use facilities are located within the territorial area of the other utility, except in the case of exceptional circumstances, economic constraints, or good engineering practices and upon written request. The parties agree to request Commission approval of interim service that lasts or is expected to last for more than one year. Of course, if the parties wish to make a permanent boundary change, they shall seek prior approval from the Commission.

Section 2.6 of the agreement outlines the treatment for utility compensation regarding transferred customers and the treatment of customer deposits. This section details the timing of payment, the cost of facilities and calculation of lost revenues. Section 2.8 of the agreement accounts for any differences in the amount of customer deposit required by each utility. ORDER NO.PSC-95-0351-FOF-EU DOCKET NO. 940331-EU PAGE 3

Upon review, we find that the Joint Petition for Approval of Territorial Agreement between Florida Power Corporation and Suwannee Valley Electric Cooperative, Inc. is in the public's interest and that its adoption will further the Commission's policy of avoiding unnecessary and uneconomic duplication of facilities.

The territorial agreement provides that it shall remain in effect for a period of 20 years from the date of Commission approval.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the territorial agreement executed by Florida Power Corporation and Suwannee Valley Cooperative is hereby approved as discussed in the body of this order. It is further

ORDERED that the parties shall request Commission approval of interim service that lasts or is expected to last for more than one year. It is further

ORDERED that the agreement shall remain in effect for a period of 20 years from the date of this Order, unless modified by the Commission. It is further

ORDERED that this Order shall become final and effective and this docket shall be closed unless an appropriate petition for formal proceedings is received by the Division of Records and Reporting, 101 East Gaines Street, Tallahassee, Florida 32399-0870, by the close of business on the date indicated in the Notice of Further Proceedings or Judicial Review.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

The action proposed herein is preliminary in nature and will not become effective or final, except as provided by Rule 25-22.029, Florida Administrative Code. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, as provided by Rule 25-22.029(4), Florida Administrative Code, in the form provided by Rule 25-22.036(7)(a) and (f), Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting, 101 East Gaines Street, Tallahassee, Florida 32399-0870, by the close of business on April 4, 1995.

In the absence of such a petition, this order shall become effective on the day subsequent to the above date as provided by Rule 25-22.029(6), Florida Administrative Code.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party substantially affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the effective date of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure.
