In a letter addressed to you dated March 15, 1995, Southern Bell furnished its 1994 surveillance report and identified a specific amount of 1994 earnings that would be available for sharing with our ratepayers as a result of Order No. PSC-94-0172-FOF-TL, entered in Docket No. 920260-TL, Comprehensive Review of Revenue Requirements and Rate Stabilization Plan of Southern Bell Telephone and Telegraph Company.

In that letter we proposed a method for returning the funds that were to be shared with our ratepayers. With minor modifications, the methodology was the same as was used for earlier refunds in the proceeding.
