In Re: Application for amendment of Certificates Nos. 84-W and 73-S in Orange County by SOUTHERN STATES UTILITIES, INC.

ORDER AMENDING CERTIFICATES TO INCLUDE ADDITIONAL TERRITORY AND CLOSING DOCKET

BY THE COMMISSION:

Southern States Utilities, Inc. (Southern States or utility) is a Class A utility that provides water and wastewater service to approximately 78,962 water customers and 26,696 wastewater customers in 28 counties in Florida. The utility's 1993 annual report shows an annual operating revenue of \$50,521,158 and a net operating income of \$1,029,574.

On April 28, 1993, Southern States filed an application with this Commission to amend Water Certificate No. 84-W and Wastewater Certificate No. 73-S to add areas in Orange County that are presently served. Section 367.045(2), Florida Statutes, provides that a utility may not extend its service outside the area described in its certificate of authorization until it has obtained an amended certificate of authorization from the Commission. By serving customers outside its certificated territory, Southern States violated that provision. Docket No. 921014-WS addressed the violation and allowed our staff to process the amendment administratively if the area was included in that docket. We have verified that these systems were mentioned in that docket.

Except as noted above, the application is in compliance with Section 367.045, Florida Statutes, and other pertinent statutes and provisions of the Florida Administrative Code concerning an application for amendment of certificate. The application contains a filing fee in the amount of \$300, as prescribed by Rule 25-30.020, Florida Administrative Code. Southern States provided evidence that it owns the land upon which its facilities are located, as required by Rule 25-30.036, Florida Administrative Code.

Adequate service territory and system maps and a territory description have been provided, as prescribed by Rule 25-30.036, Florida Administrative Code. The utility has extended their existing water and wastewater lines to serve the additional territory. The additional territory which Southern States is

requesting to serve in Orange County is described in Attachment A of this Order. The utility has submitted an affidavit consistent with Section 367.045(2)(d), Florida Statutes, that it has tariffs and annual reports on file with the Commission.

Southern States has provided proof of compliance with the noticing requirements of Rule 25-30.030, Florida Administrative Code. The local planning agency was provided notice of the application and did not file a protest to the amendment. Objections to the application were received on May 20, 1993, by the City of Winter Park, and on May 26, 1993, by Orange County. On November 24, 1993, the City of Winter Park withdrew its objection to the application. On January 23, 1995, we received Orange County's letter withdrawing its objection.

The utility has extensive experience in the water and wastewater industry. As mentioned earlier, the utility currently services approximately 78,000 customers in 28 counties in Florida. The Department of Environmental Protection has no outstanding notices of violation issued for these systems. Since these customers are already being served by this utility, it is apparent that the utility has the capacity to serve them. Consequently, we believe the utility has demonstrated the financial and technical expertise to provide quality service to these customers. The utility has filed revised tariff sheets incorporating the additional territory into its tariff and returned its certificates for entry reflecting the additional territory. Therefore, we find that it is in the public interest to amend Water Certificate No. 84-W and Wastewater Certificate No. 73-S to include the territory described in Attachment A of this Order, which by reference is incorporated herein.

On May 26, 1994, SSU filed a systemwide price index increase, pursuant to Section 367.081(4)(a), Florida Statutes. The increase was approved and the rates became effective on July 24, 1994. We find that the rates and charges approved by us shall be applied to customers in the new service territory until authorized to change by this Commission in a subsequent proceeding. Since no further action is neccessary, this docket shall be closed.

It is, therefore,

ORDERED by the Florida Public Service Commission that Water Certificate No. 84-W and Wastewater Certificate No. 73-S, held by Southern States Utilities Inc., are hereby amended to include the territory described in Attachment A of this Order, which by reference is incorporated herein. It is further

ORDERED that Southern States Utilities, Inc. shall charge the customers in the territory added herein the rates and charges approved in its tariff until authorized to change by this Commission. It is further

ORDERED that this docket is hereby closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
