ORDER AMENDING CERTIFICATES TO INCLUDE ADDITIONAL TERRITORY AND CLOSING DOCKET

BY THE COMMISSION:

Southern States Utilities, Inc. (Southern States or utility) is a Class A utility that provides water and wastewater service to approximately 78,962 water customers and 26,696 wastewater customers in 28 counties in Florida. The utility's 1993 annual report shows an annual operating revenue of \$50,521,158 and a net operating income of \$1,029,574.

On February 10, 1995, Southern States filed an application with this Commission to amend Water Certificate No. 106-W and Wastewater Certificate No. 120-S to add areas in Lake County. The application is in compliance with Section 367.045, Florida Statutes, and other pertinent statutes and provisions of the Florida Administrative Code concerning an application for amendment of certificate. The application contains a filing fee in the amount of \$4,500, as prescribed by Rule 25-30.020, Florida Administrative Code. Southern States provided evidence that it owns the land upon which its facilities are located, as required by Rule 25-30.036, Florida Administrative Code.

Adequate service territory and system maps and a territory description have been provided, as prescribed by Rule 25-30.036, Florida Administrative Code. The additional territory which Southern States is requesting to serve in Lake County is described in Attachment A of this Order. The utility has submitted an affidavit consistent with Section 367.045(2)(d), Florida Statutes, that it has tariffs and annual reports on file with the Commission.

Southern States has provided proof of compliance with the noticing requirements of Rule 25-30.030, Florida Administrative Code. The local planning agency was provided notice of the application and did not file a protest to the amendment. No objections to the application have been received and the time for such has expired. To serve these customers the utility will extend the water and wastewater lines of the present system.

The utility has extensive experience in the water and wastewater industry. As mentioned earlier, the utility currently services approximately 78,000 customers in 28 counties in Florida. The Department of Environmental Protection has no outstanding notices of violation issued for these systems. The utility's water plant currently has capacity of 2.88 million gallons per day (mgd) with an existing demand of .106 mgd. To meet Lake County's fire flow requirement the utility is currently in the process of designing and planning for the installation of additional high service pumps. The wastewater treatment plant has a capacity of .250 mod with the disposal capacity of the ponds rated at .150 mgd. Current flows at the wastewater treatment plant is .095 mgd. TO accommodate growth the utility believes that the ponds can be rerated to permit a total of about .250 mod of effluent disposal capacity, and that the plant can be easily expanded at the present Therefore, it is apparent that the utility has 23 acre site. capacity in the short term and can build the capacity as the need arises to serve this area in the future. Consequently, we believe the utility has demonstrated the financial and technical expertise to provide quality service to these customers.

The utility has filed revised tariff sheets incorporating the additional territory into its tariff and returned its certificates for entry reflecting the additional territory. Therefore, we find that it is in the public interest to amend Water Certificate No. 106-W and Wastewater Certificate No. 120-S to include the territory described in Attachment A of this Order, which by reference is incorporated herein.

On May 26, 1994, SSU filed a systemwide price index increase, pursuant to Section 367.081(4)(a), Florida Statutes. The increase was approved and the rates became effective on July 24, 1994. We find that the rates and charges approved by us shall be applied to customers in the new service territory until authorized to change by this Commission in a subsequent proceeding. Since no further action is necessary, this docket shall be closed.

It is, therefore,

ORDERED by the Florida Public Service Commission that Water Certificate No. 106-W and Wastewater Certificate No. 120-S, held by Southern States Utilities Inc., are hereby amended to include the territory described in Attachment A of this Order, which by reference is incorporated herein. It is further

ORDERED that Southern States Utilities, Inc. shall charge the customers in the territory added herein the rates and charges approved in its tariff until authorized to change by this Commission. It is further

ORDERED that this docket is hereby closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
