NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On April 4, 1995, Mid-Com Communications, Inc. (Mid-Com), and American Telephone Network, Inc. (American), jointly notified this Commission that Mid-Com was in the process of acquiring substantially all of American's assets. Both companies are certified with this Commission to provide interexchange telecommunications services. The transfer of assets will not affect the services provided to American's customers. American will continue to operate under its own name, certificate and tariff and its employees will be employed by Mid-Com.

We find the transfer to be in the public interest. Accordingly, the request for approval of the transfer of assets is granted.

In the absence of such a petition, this order shall become effective on the day subsequent to the above date as provided by Rule 25-22.029(6), Florida Administrative Code.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party substantially affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the effective date of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
