WHEREAS, the Haines City City Commission requests the Florida Public Service Commission expand the local calling scope of the Haines City telephone exchange to include Lakeland, Bartow, Mulberry, Fort Meade and other communities in Polk County;

WHEREAS, there is a community of interest between Haines City customers and communities that are currently accessible only by a toll call;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HAINES CITY, FLORIDA, THAT:

Section 1: That extended calling service (ECS) be provided the citizens of Haines City to all locations within Polk County.
