OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission has issued Data Request No. 65 dated September 6, 1995; Request No. 71 dated September 11, 1995; and Request No. 88 dated September 27, 1995. Staff requests, among other things, that BellSouth furnish the following information:

2. Staff Audit Request No. 65 - "Please explain why there are different prorates from BST HDQ for the month of January '94 and the rest of the year?; Please explain how you calculated the BST general allocator provided in answer to Request 63 (formula and numbers used)?; See attached questions re: FCC Order 95-31 about the general allocator at BSC."

3. Staff Audit Request No. 71 - "Please provide trial balances, and financial statements from BSS, and BSC, regarding the other Regulatory Adjustment to N.O.I. expenses. See attached schedule."

4. Staff Audit Request No. 88 - "Provide further back up to the attached items (13 pages) Acct. 6611 - DOCUMENT NUMBER DATE
300; Acct. 6623 - 203, 204, 206, 220, 208, 210, 0999421 OCT 10 1995

FPSC-RECORDS/REPORTING

216, 218; Acct. 6411 - Item 270; Acct. 6712 - 170, 173, 174, 175, 176, 178, 180, 182, 184, 186, 189; Acct. 6722 - 192, 195, 196, 194; Acct. 6723 - 223, 224, 225, 226; Acct. 6724 - 237; Acct. 6725 - 262, 266, 264, 265, 263."

5. The information requested includes information concerning non-regulated companies and other confidential business information. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3) and (3)(b), Florida Statutes.

6. Consequently, because this information contains proprietary information, BellSouth is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff requests are attached hereto.
