

A RESOLUTION OF THE CHARLOTTE COUNTY, FLORIDA, BOARD OF COUNTY COMMISSIONERS REQUESTING THE FLORIDA PUBLIC SERVICE COMMISSION TO APPROVE AND ORLER EXTENDED AREA CALLING SERVICE BETWEEN CERTAIN TELEPHONE EXCHANGES WITHIN CHARLOTTE COUNTY.

## RECITALS

WHEREAS, the Charlotte County Board of County Commissioners represents the interests of all citizens of Charlotte County; and

WHEREAS, Charlotte Courty is a political subdivision of the State of Florida located on the Southwest Florida Gulf coast, containing several developed areas clustered around Charlotte Harbor, including the areas of Port Charlotte, Englewood, and Cape Haze, the City of Punta Gorda, and the island of Boca Grande; and

WHEREAS, the Charlotte County Board of County Commissioners believes that there is a more than normal degree of a shared community of interest, both personal and business, between the Charlotte County citizens of the above-referenced five areas: they are all integral parts of Charlotte County's economic, cultural, and civic community and all share the same Charlotte County seat and Courthouse, located in Punta Gorda, and the Charlotte County Administration Center, located in Port Charlotte; and

WHEREAS, the existence of a regular long distance charge for telephone service between these areas of Charlotte County inhibits the integration and growth of Charlotte County; and

WHEREAS, the expanded calling scope of Extended Area Calling Service would complement the needs of both business and residential interests in the expanding areas of Charlotte County, which are increasingly interdependent by both the strands of commerce and personal relationships and, therefore, share the need for economical methods of communication between the various areas of Charlotts County; and

WHEREAS, the Charlotte County Board of County Commissioners believes that there is a sufficient desire by all of the telephone subscribers in Charlotte County to warrant establishing Extended Area Calling Service or other tollalternative arrangements between the above-referenced areas and exchanges within Charlotte County, as evidenced by the attached copies of letters, petitions, and newspaper articles, labeled as composite Exhibit "A" and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners in Charlotte County:

Section 1. That Charlotte County requests the Florida Public Service Commission to approve and order the implementation of Extended Area Calling Service or other toll-alternative arrangement between the following exchanges within the boundaries of Charlotte County, as follows:

- a. from the Boca Grande exchange to the Englewood, Port Charlotte, and Punta Gorda exchanges (Extended Area Calling Service already exists between the Boca Grande and the Cape Haze exchanges);
- b. from the Cape Haze exchange to the Punta Gorda exchange (there is presently no charge for calls between the Cape Haze and the Englewood exchanges, and Extended Area Calling Service alread, exists between the Cape Haze exchange and the Boca Grande and Port Charlotte exchanges);
- c. from the Englewood exchange to the Boca Grande, Port Charlotte, and Punta Gorda exchanges (there is presently no charge for calls between the Englewood and the Cape Haze exchanges);
- d. from the Port Charlotte exchange to the Boca Grande and Englewood exchanges (there is presently no charge for calls between the Port Charlotte and the Punta Gorda exchange, and Extended Area Calling Service already exists between the Port Charlotte exchange and the Cape Haze exchange; and
- e. from the Punta Gorda exchange to the Boca Grande, Cape Hize, and Englewood exchanges (there is presently no charge for calls between the Punta Gorda and Port Charlotte exchanges).

Section 2. The Clerk is directed to provide a copy of this Resolution to the Florida Public Service Commission.


