Extended rate calling plan

Dear Ms. Clark:

I am writing to you on behalf of the approximately 125,000 residents of District 98 of the Florida House of Representatives. This district, which I have the honor of representing, consists primarily of the cities of Sunrise and Plantation in west Broward County.

My specific concern is with regard to your forthcoming meeting of the Public Service Commission on September 26, 1995. I am unable to attend your meeting personally and so I am taking the liberty of writing to you instead.

The Southern Bell Company, has made a proposal to your Commission to reduce the rates on 288 calling service routes. In essence, it would change telephone calls that are now considered long distance or toll calls to flat rate calls at twenty five cents each, with no time limit. It is my understanding that this is a bare rate reduction, with no offset increase in any other service area. Among the new service lines that would open up as flat rate calls in my district would be calls to Boca Raton, Delray Beach, Boynton Beach, Homestead, and Perrine.

You must understand also that I have a high percentage of retirees in my district living on fixed incomes, and for whom every penny they can save on their long distance telephone bills means that much more they can spend on food and clothing.

A prime example would be my own mother-in-law, who lives in Sunrise as a retiree and whose only income is social security. She regularly calls her brother-in-law and sister-in-law, her closest relatives and friends outside of my immediate family. They happen to live in Boynton Beach. It would therefore be a significant savings to her, plus an emotional boon, to be able to now speak to them several times a week instead of once, and for as long as she needs.

Sounds like a great idea, doesn't it? But apparently not according to your staff, who have recommended to you that you approve only 70 of these 288 proposed routes.

I cannot fathom why your staff would urge you to take a course of action which will cost my constituents more money than Southern Bell wants to charge them, when allowing the full proposed reduction would cost no one any additional expense.

Coming as it does on the heels of the 954 area code debacle, it is beginning to look to me as if your Commission is out to get Broward County. I am here to tell you that there are eighteen Representatives and Senators, who have plenty of friends, that will not allow this to happen.

I urge you, on behalf of my mother-in-law and the other 124,999 residents of the cities of Sunrise and Plantation in my district, to override your staff's recommendation, and agree to allow all 288 extended calling service routes to be approved.
