C) DOCKET NO. 951107-EI - Application of Florida Power & Light Company for approval to issue, sell and/or exchange any combination of long term debt and equity securities and/or assume liabilities or obligations as guarantor, endorser or surety during the twelve months ending December 31, 1996. The issuance of equity and long term debt obligations shall not exceed \$900 million in the aggregate. FPL also seeks authority to enter into forward refunding or forward swap contracts during calendar year 1996 and, in conjunction with those forward contracts, seeks authority to issue and sell up to \$139 million of securities through December 31, 2001.
