PETITION FOR APPROVAL OF FLORIDA PUBLIC UTILITIES COMPANY'S PURCHASED GAS COST RECOVERY FACTORS

Florida Public Utilities Company ("the Company"), by and through its undersigned attorneys and pursuant to the requirements of this docket, hereby petitions the Commission for approval of the Company's purchased gas cost recovery factors for the period April, 1996 through March, 1997. In support thereof, the Company states:

- 3) Pursuant to the requirements of this Docket, the Company has prefiled the purchased gas cost recovery forms supplied by the Electric & Gas Department in a manner consistent with the Department's instructions.
- 4) As indicated in the prefiled testimony and schedules, the final true-up amount for the period April, 1994 through March, 1995 is an underrecovery of \$945,255. For the period April, 1995 through March, 1996, the company estimates an overrecovery of \$1,371,194. Based on this data the total net overrecovery to be refunded during the April, 1996 through March, 1997 period is \$425,939. Based upon projected therm sales for April, 1996 through March, 1997, it will be necessary to adjust the recovery factor to refund this overrecovery on the basis of these projections.
- 5) The Purchased Gas Cost Recovery Factor for this period will be a maximum of 38.519¢ per therm.

WHEREFORE, Florida Public Utilities Company herewith petitions the Commission to approve the foregoing purchased gas cost recovery factors, to be applied to customer bills for the period April, 1996 through March, 1997, and to billings thereafter until other purchased gas cost recovery factors are approved by the Commission.
