- 3) Pursuant to the requirements of this Docket, the Company has prefiled revised purchased gas cost recovery forms supplied by the Electric & Gas Department in a manner consistent with the Department's instructions.
- 4) As indicated in the prefiled revised forms, as of the end of March, 1995 the Company will have experienced an underrecovery of \$1,345,359 for the period April, 1994 through March, 1995, and an estimated underrecovery of \$304,917 for the period April, 1995 through March, 1996. The final total true-up for the projected period April, 1996 through March, 1997 is an underrecovery of \$1,040,442. A revised true-up collection factor of 3.430¢ per them has been calculated.
- 5) As indicated in the prefiled revised forms, the revised maximum purchased gas cost recovery factor is 37.543¢ per therm for the period April, 1996 through March, 1997. This includes projected cost of gas purchased, prior period true-up, and revenue tax factors, and are based upon projected sales.

WHEREFORE, West Florida Natural Gas Company petitions the Commission to approve the foregoing revised purchased gas cost recovery factor, to be applied to customer bills for the period April, 1996 through March, 1997, and to billings thereafter until

another purchased gas cost recovery factor is approved by the Commission.
