A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MADISON COUNTY, FLORIDA, EXPRESSING THE CONCERN OF THE CITIZENS OF MADISON COUNTY, FLORIDA, REGARDING THE LONG DISTANCE PHONE SERVICE OFFERED IN MADISON COUNTY.

WHEREAS, it has been brought to the attention of the Madison County Board of Commissioners that some citizens of Madison County do not enjoy the privilege of calling the Tallahassee area without benefit of long distance charges, and

WHEREAS, the Madison County Board of Commissioners feels it's responsibility to provide equal service to all citizens of Madison County, and


WHEREAS, other citizens of the County are provided this privilege by the local phone service, and
