<u>ISSUE 1</u>: What elements should be made available by Sprint-United/Centel and GTEFL to MFS on an unbundled basis (e.g., link elements, port elements, loop concentration, loop transport)?

POSITION:

Unbundled LEC loops, ports, loop concentration and loop transport should be made available at this time.

ISSUE 2: What are the appropriate technical arrangements for the provision of such unbundled elements?

POSITION:

Unbundled elements should be made available at interconnection points between the LEC and the ALEC networks.

<u>ISSUE 3</u>: What are the appropriate financial arrangements for each such unbundled element?

POSITION: FCTA takes no position at this time.

<u>ISSUE 4</u>: What arrangements, if any, are necessary to address other operational issues? <u>POSITION</u>: The LEC should provide ordering, repair, testing and any other administrative systems needed on an automated basis.
