NOW COMES AT&T Communications of the Southern States, Inc. (hereinafter "AT&T") and, pursuant to Rule 25-22.039, Florida Administrative Code, files this Petition for Leave to Intervene with the Florida Public Service Commission (hereinafter the "Commission") in the above-referenced docket. AT&T respectfully requests that the Commission grant this petition, designating AT&T a party of record and affording it all applicable rights under Florida law and the rules and regulations of this Commission. In support thereof, AT&T respectfully shows as follows:

AT&T is a telecommunications company that has been duly certificated by the Commission as an alternative local exchange telecommunications company ("ALEC") and an interexchange company ("IXC") in Florida. As such, AT&T is subject to the rules, regulations, and orders of the Commission, and such rules, regulations, and orders impact AT&T's ability to provide local exchange telecommunications service and intrastate interexchange telecommunications service.

4. The above-referenced docket was opened for the purpose of developing and implementing a permanent number portability mechanism in Florida pursuant to Section 364.16(4), Florida Statutes. Such a mechanism will, at a minimum, allow local exchange customers in Florida to change local service providers without such customers having to change their local telephone number. After this docket was opened, the federal Telecommunications Act of 1996 (the "Act") was enacted. The Act requires all local exchange companies to provide number portability, to the

extent technically feasible. As an ALEC and IXC, any decisions reached in this docket will necessarily affect the substantial interests of AT&T.
