Our Division of Communications attempted to reach each company by telephone but the companies' phones had either been disconnected, the companies have not responded, or the companies' number was not published. Neither the companies nor the company liaisons had listings in directory assistance.

Rule 25-24.520(1)(a) and (b), Florida Administrative Code, requires a pay telephone company to inform this Commission within 10 days if there is a change in the company name, its address, its telephone number, or its Commission contact person. By failing to inform this Commission of changes in address and telephone number; the companies are in apparent violation of Rule 25-24.520(1)(a) and (b), Florida Administrative Code.

Accordingly, we order each company to pay a \$100 fine and provide the Commission with the information required by Rule 25-24.520(1)(a) and (b), Florida Administrative Code, within 30 days of the date this Order becomes final. The fine is to be paid to the Florida Public Service Commission and forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. When a company complies, that docket will be closed. If a company fails to comply with this Order, its certificate will be cancelled and that docket will be closed. A protest by one of the companies in its docket will not prevent this Order from becoming final with respect to the other dockets.
