

PETITION TO CORRECT NAME REFLECTED ON CERTIFICATE NO. 3171

The Furst Group, Inc., hereby petitions the Florida Public Service Commission to correct the name reflected on Certificate No. 3171 granted to The Furst Group, Inc. by Order No. PSC-93-0666 on May 21, 1993. Certificate No. 3171 authorizes The Furst Group, Inc. to provide interexchange telecommunications service throughout the State of Florida.

It has come to the attention of The Furst Group, Inc., that its Certificate No. 3171 incorrectly reflects the company's name as "The Furst Group Headquarters, Inc." There has been no change in the corporate status or name or structure of the company since the application for the company's certificate for authority to provide interexchange telecommunications service was initially filed. Apparently, there was a simple clerical mistake made at some point that resulted in Certificate No. 3171 reflecting the name "The Furst Group Headquarters, Inc." The company's corporate name has always been "The Furst Group, Inc."

WHEREFORE, The Furst Group, Inc. hereby petitions the Commission to correct the name reflected on Certificate No. 3171 to "The Furst Group, Inc."
