Dear Ms. Bayo,


On June 17, 1996 the Public Service Commission issued an Order Acknowledging Sale and Cancelling Water Certificate and Closing Docket. Prior to that date the City of Tavares turned down the Contract to Purchase without issuing us a cancellation. The Contract is now expired, null and void.

A new Contract for Purchase is now being prepared by the Glenn's Cove Water System, Inc., a new non-profit corporation, of which Jay C. McClendon, II is the President. I understand the new corporation has recently contacted your office for the application forms needed for the purchase.
