COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Amended Notice of Intent to Request Specified Confidential Classification.

1. On July 19, 1996, AT&T Communications of the Southern States, Inc. ("AT&T") advised the Florida Public Service Commission that AT&T would be filing documents with the Commission containing information considered to be confidential and proprietary to BellSouth on July 24, 1996 in the above captioned docket (Tabs 346-435), however, those documents were not filed with the Commission until Monday, August 12, 1996.
