We are in receipt of your deficiencies letter of July 9, 1996. Our response is in the order presented in your letter.

(1) Statement of Financial and Technical Ability - Crystal River Utilities, Inc. has been successful in attracting qualified licensed operators from the area where the system is physically located to operate the systems on a contract basis. We will likely hire H2O Utility Services, Inc. which currently operates and maintains over eighty systems in Florida. The operator's state license number is #COA5894.

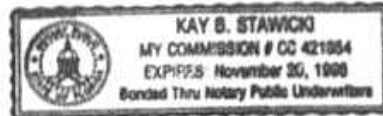

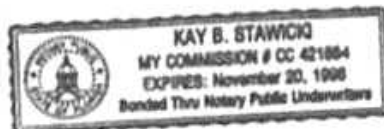

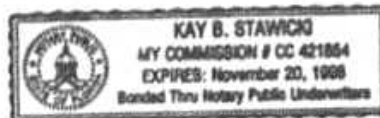
