ORDER REVISING ORDER NO. PSC-96-1230-PCO-WS

Order No. PSC-96-1230-PCO-WS, issued October 1, 1996, established controlling dates to govern this proceeding. As established by that Order, prehearing statements were inadvertently scheduled to be filed several days before the filing of staff's direct testimony and exhibits, if any.

Staff and United Water Florida Inc., (UWF or utility) propose that staff's testimony and exhibits should be filed before the filing of prehearing statements. This will afford an opportunity for parties to review staff's testimony and exhibits prior to formulating their issues and positions for their prehearing statements. Moreover, staff and UWF have agreed to hold an informal, pre-prehearing conference on January 3, 1997. Because this is the same date upon which rebuttal testimony is scheduled to be filed, they propose that rebuttal testimony should instead be filed by January 8, 1997. As of the date of this Order, there are no other parties of record to this docket.

Finding the above-described proposals to be reasonable, Order No. PSC-96-1230-PCO-WS is hereby revised to reflect same. The following revised dates shall govern in this docket:

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
