GTE FLORIDA INCORPORATED'S NOTICE OF INTENT TO SEEK CONFIDENTIAL CLASSIFICATION

GTE Florida Incorporated (GTEFL) hereby gives notice of its intent to seek confidential classification of certain material contained in GTEFL's response to Sprint's First Set of Interrogatories and Dala Requests, No. 1C, in this matter.

The materials covered by this Notice consist of directory assistance and extended area service agreements between GTEFL and United Telephone Company. This Notice exempts this material from §119.07(1) of the Florida Statutes and §24(a), Art. 1 of the State Constitution and protects it from public disclosure. All of this information falls within Florida Statutes §364.183(3)(e), which defines the term "proprietary confidential business information" to include "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of that information." In a competitive business, any such knowledge obtained about a competitor can be used to the detriment of the entity to which it pertains. This unfair advantage skews the operation of the market, to the ultimate detriment of the consumer.

GTE will follow up this Notice with a request for permanent confidential classification within 21 days. That request will include a detailed, line-by-line justification for the confidentiality of the materials submitted under the Notice.
