I have taught graduate level courses in 15 regulation at the University of Pennsylvania and Princeton 16 University, in addition to my work at the University of Texas. 17 18 During the Carter Administration, I served as Senior Staff Economist 19 on the Council of Economic Advisors and as advisor to the Chairman 20 of the Civil Aeronautics Board. During the last twenty years, I have 21 carried out extensive research in the areas of regulation, industrial 22 organization, and microeconomic theory.
