This letter is intended to provide you with an update as far as the progress that is being made to convert Normandy Village Utility Company into a tax exempt, not-for-profit entity.

The process we are undertaking has three elements. First, the new not-for-profit entity is to be formed, which has been done. Please find enclosed herewith a copy of our "acknowledgment" copy of the Articles of Incorporation of Normandy Village Utility Co-Op, Inc.

The next step in the process is to obtain an Internal Revenue Service ruling that the new not-for-profit entity is exempt from all federal income taxes. We are currently in the process of completing the necessary form (Treasury Form 1024) in this regard. Personnel at Normandy Village Utility Company are working on gathering together the necessary information to complete the form, and as soon as I am in receipt of it, I will then incorporate it into the ruling request and will submit the ruling request to the Internal Revenue Service.

Once the favorable determination letter has been obtained from the Internal Revenue Service, the final step will be to merge Normandy Village Utility Company into the new tax exempt entity, Normandy Village Utility Co-Op, Inc., such that the tax exempt entity will be the surviving corporation. As such, Normandy Village Utility Co-Op, Inc. will then have title to all of the existing utility assets of the original company.

ARTICLES OF INCORPORATION

OF

NORMANDY VILLAGE UTILITY CO-OP, INC.

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I.

The name of the corporation shall be Normandy Village Utility Co-Op, Inc.

The principal place of business of this corporation shall be 1828 Fouraker Road, Jacksonville, Florida 32221.

ARTICLE II.

The period of the duration of this corporation is perpetual, unless dissolved according to law.

ARTICLE III.

The purposes for which the corporation is organized are:

To operate and maintain on a non-profit, cooperative basis the

water and sewer utility assets serving the Normandy Village subdivision and certain adjacent neighborhoods located in Jacksonville, Florida.

ARTICLE IV.

The qualifications for members and the manner of their admission are as provided in the Corporate By-laws, as same may be adopted and amended from time to time.

ARTICLE V.

The Directors of this corporation shall be elected in accor-




