1. In a Memorandum dated September 23, 1991, the Florida Public Service Commission ("Commission"), requested that all local exchange companies submit pay telephone data on a quarterly basis for both LEC and NON-LEC pay stations.

2. The information contained in this quarterly report is proprietary and entails information that is clearly confidential and proprietary under Florida Statutes, Section 364.183.
