PURPOSE AND PROCEDURE

The purpose of this hearing shall be to permit Florida Power Corporation and Tiger Bay Limited Partnership to present testimony and exhibits in support of their agreement for the purchase and sale of the Tiger Bay Cogeneration facility and the termination of related purchased power contracts; to permit any intervenors to present testimony and exhibits concerning this matter; and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony. The proceedings will be governed by the provisions of Chapter 120, Florida Statutes, and Chapter 25-22, Florida Administrative Code.
