ALLTEL FLORIDA, INC.'S WITHDRAWAL OF PETITION AND NOTICE OF VOLUNTARY DISMISSAL

Pursuant to Florida Rules of Civil Procedure 1.420(a)(1), ALLTEL Florida, Inc. ("ALLTEL") hereby withdraws its Petition, dated September 6, 1996, and voluntarily dismisses its action in this docket. As grounds therefor, ALLTEL notes that the FCC's recent payphone order (<u>Report and Order</u>, CC Docket Nos. 96-128 and 91-35, released September 20, 1996) would appear to preempt a FPSC order mandating the routing of any or all interLATA calls (except 0-) to the incumbent LEC and that the matters for reconsideration of that order have now been decided. ALLTEL reserves the right to seek relief similar to the relief it requested in the Petition if the federal law changes in the future.
