

PREHEARING STATEMENT OF HAINES CITY

In accordance with Commission Order PSC-96-1034-PCO-TL issued August 8,

1996, the City of Haines City files this Prehearing Statement.

1. All Known Witnesses

The City of Haines City filed direct testimony by the following witnesses:

James C. Brantley. Executive Director of the East Polk County Committee of

100. Mr. Brantley addresses economic growth of the Northeast Polk County area,

impact of countywide extended area service on existing and potential businesses and community of interest.

George H. Carefoot, President of First National Bank of Polk County. Mr.

Carefoot addresses growth of the Haines City area, impact of countywide extended

area service on businesses and additional factors effecting community of interest.

James J. DeGennaro. Senior Vice President of the Central Florida

Development Council. Mr. DeGennaro will address business recruitment and retention, impact of countywide extended area service and additional factors for consideration regarding community of interest.

Jim Nelson. Member of Polk County School Board elected countywide and manage of Haines City Publix Suparmarket. Mr Nelson will discuss his experience in public service and the impact of countywide extended area service on business, employment and obtaining county, state and federal services.

Ben Saag. Assistant to the City Manager and Main Street Director for the City of Haines City. Mr. Saag will discuss his role in the local business community and the negative concerns and problems created by lack of countywide extended area service as well as the positive impact that implementation of countywide extended area service will have on Northeast Polk County.

<u>Walter W. Storm</u>. Jirector-Elderly Service Division, Polk County Board of County Commissioners. Mr. Storm will discuss the impact of countywide extended area service on the elderly and their efforts to obtain services provided.

Richard Thomas Wheeler. Chief of police for the City of Haines City. Mr. Wheeler will discuss law enforcement and the impact county wide extended area service will have on law enforcement in fighting crime.

Elizabeth Ann Toney. City Manager of the City of Haines City. Miss Toney will discuss the importance of county wide extended service for Haines City and its relationship to "Communities of interest" with other parts of Polk County. The impact of countywide extended area service on the economy and growth potential of the area and will comment on the reasons petitioner believes that the telephone traffic data

between Haines City and other areas of Polk County are not a true representation of the actual traffic low.

2. All Known Exhibits

The City of Haines City has not been given access to data that has been prepared or compiled by the providers of telephone service, due to their seeking classification of that information as confidential. However, the City intends to use any exhibits that are produced or used by any other party or witness as applicable.

3. Statement of Basic Position

Countywide extended area service should be implemented. It is warranted by the present (part of which we not counted due to cellular telephones and providers other than GTE) and potential telephone traffic. Sufficient community of interest exists and more will be created by countywide extended area service. If the vote for countywide extended area service fails then extended calling service, or an alternative proposal should be implemented.

4. Issues and positions

Issue 1. Is there a sufficient community of interest to justify implementing EAS, as currently defined in the Commission rules, or implementing ECS, or an alternative toll proposal on any of the following routes:

County seat of Polk County

State and Federal offices serving the area

Position: There is a sufficient community of interest to warrant a vote on EAS for each of the routes. If the vote fails, ECS should be implemented on each of the routes.

Position: Yes, there are other community of interest factors which include,

but are not limited to, (1) Governmental Services, (2) Medical Services, (3)

Professional Services, (4) Commerce, (5) Employment, (6) Transportation, (7) Social

Interaction, (8) Schools, (9) Countywide Calling, and (10) Natural Barriers.

Issue 3. If a sufficient community of interest is found on any of these routes, what is the economic impact of each plan on the customer and the company (summarize in chart form and discuss in detail)?

Position: Existing toll rates inhibits economic development along the routes EAC or ECS will have a positive economic impact on the community.

issue 4. Should subscribers be required to pay an additive as a prerequisite to implementation of EAS? If so, how much of a payment is required and how long should it fast?

Position: The Commission should put the 25/25 plan to a vote. Any increase should last no more than 4 years.

Issue 5. If a sufficient community of interest is found, what are the appropriate rates and charges for the plan to be implemented on those routes or route?

Position: The 25/25 plan for EAS can be calculated from existing rates. ECS would not change local rates.

5. Other Matters

The City of Haines City has no pending motions, and no issues have been stipulated. There are no requirements set forth in the order establishing procedure that cannot be complied with.
