The Florida Public Service Commission ("FLPSC") staff has brought to BellSouth's attention a discrepancy between the collocation rates filed by BellSouth on April 2, 1997, in the BellSouth-AT&T Interconnection Agreement and those filed by AT&T in their April 4, 1997, filing. The discrepancy was not intentional. For some reason, the Security Escort rates were inadvertently left off of BellSouth's Table 2.
