NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding in accordance with Rule 25-22.029, Florida Administrative Code.

Each of the entities listed in the caption of this Order filed an application for a Certificate of Public Convenience and Necessity to provide interexchange telecommunications service. The respective applications contain the required background information and the proposed tariffs. Having considered these applications, it appears that it is in the public interest to grant, to these entities, certificates to provide interexchange telecommunications service.
