Notice is hereby given on APRIL 28, 1997, pursuant to Section 367.045, Florida Statutes, of the application of ORTEGA UTILITY COMPANY to amend its Water Certificate No. 223-W and Wastewater Certificate No. 167-S to ADD territory in DUVAL County, Florida as follows:

PARCEL 1: A PORTION OF THE SOUTHEAST 1/4 OF SECTION 19 TOGETHER WITH A PORTION OF THE NORTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 30.
