We are in receipt of your letter dated April 19, 1997, in which you objected to Placid Lakes Utilities, Inc.'s application for amendment of its service area. By letter dated May 30, 1997, Mr. J. Travis Coker of the Division of Water and Wastewater responded to the concerns set out in your objection. As stated by Mr. Coker, the Department of Environmental Protection has agreed to fund a major portion of the construction, with the remaining costs being paid by new customers connecting to the system. Therefore, the extension should not cause the rates of the current customers to increase.

You were also concerned that water pressure would not be sufficient to serve the current customers and the customers in the additional territory. Because Placid Lakes Utilities, Inc. has installed another well and additional plant to serve the area, low water pressure should not be a problem. With regard to your concern over the condition of Catfish Creek Road during construction, ACK _ it is my understanding that this should not affect the residents of Tangerine Road since the construction will be beyond their homes.

As a follow-up to Mr. Coker's letter, I attempted to obtain a telephone number for you so that CAF we could discuss any remaining concerns which you may have. However, directory assistance does CMU not have a listing for you. I then called Placid Lakes Utilities, Inc. to see if they had a telephone CTR ____ number for you. At that time, I was informed that you no longer live at 250 Tangerine Road. EAG _____ LEG _____are not affected by Placid Lakes Utilities, Inc.'s proposed extension.
