Dear Sir or Madam:

This firm represents SmarTalk TeleServices, Inc. ("SmarTalk") with respect to its regulatory compliance matters. SmarTalk received authority from the commission to operate as a reseller of long distance and other intrastate telecommunications services on June 12, 1995, in docket number 95-0350-TI. Pursuant to SmarTalk's current tariff, SmarTalk offers various debit card and 1+ services with the majority of revenues generated by sales of debit card services.

This letter is written to notify the commission that on May 31, 1997, and May 24, 1997 SmarTalk acquired GTI Telecom, Inc. ("GTI") and SmarTel Communications, Inc. ("SmarTel") respectively, pursuant to separate merger agreements. GTI received authority from the commission to offer debit card services on May 24, 1993. SmarTel received authority from the commission to offer debit card services on January 12, 1996 in docket number 951144-TI. Both GTI and SmarTel have tariffs on file with the commission which set forth the rates for their respective debit card products.

SmarTalk respectfully requests to adopt the GTI and SmarTel tariffs under its SmarTalk tariff and that the authority issued to GTI and SmarTel be canceled. The former services provided by GTI and SmarTel will be offered by SmarTalk, the surviving corporation. The names GTI and SmarTel will no longer be used in connection with these products, except as such names are used on cards currently in circulation.
