Issue 1: Should Florida Power & Light (FPL or Company) be allowed to implement its proposed depreciation rates on a preliminary basis at January 1, 1997?

Recommendation: Yes. FPL should be allowed to implement the proposed rates for investment at the six steam generation sites analyzed in this filing, shown on Attachment A of staff's recommendation, original page numbers 4 - 9, on a preliminary basis at January 1, 1997. The effect of these proposals will increase annual depreciation expense by an estimated \$20 million annually, based on January 1, 1997 investments and reserves. The rates and resultant expenses will be trued up when final action is taken by this Commission, scheduled for January, 1998.
