Excel Communications, Inc. and Telco Communications Group, Inc. (collectively the "Applicants") submit this letter to express their appreciation of the Commission's expedited consideration of the application filed in the above-referenced proceeding. The Applicants appreciate the Commission's efforts to consider the above-referenced application in an expedited manner. The Commission's staff has been extremely helpful in working with the Applicants in processing the application and has astutely recognized the actual business demands of transactions of this nature which require regulatory approvals to be obtained on an expedited basis.

We would also like to take this opportunity to clarify certain points set forth in the AFA \_\_\_\_\_ Commission's Notice of Proposed Agency Action, Order Approving Merger ("Order") issued July 31, 1997, in the above-referenced proceeding. With respect to the Commission's Order, the \_\_\_\_\_ Applicants note that on page 2 of the Order, the Commission states that "EXCEL Telecommunications, Inc. . . . will merge with E-Sub, Inc. . . . leaving EXCEL Telecommunications. Inc., ... as [the] surviving subsidiary] of New RES, Inc.," and that "EXCEL Telecommunications CMU. CTR \_\_\_\_ Inc. . . . will survive as a wholly owned subsidiary] of New RES, Inc."

> The Applicants would like to clarify that it is EXCEL Telecommunications, Inc.'s indirect parent, EXCEL Communications, Inc. that is merging with E-Sub, Inc. and will survive as a wholly owned subsidiary of New RES, Inc. EXCEL Telecommunications, Inc. will remain a wholly owned subsidiary of EXCEL Telephone, Inc., which, in turn, will remain a wholly owned subsidiary of EXCEL Communications, Inc. Although we have no reason to believe that this typographical error in any way changes or affects the Commission's grant of EXCEL and Telco's transfer application,
