In accordance with our conversation this morning, I am writing to state the position of K.W. Resort Utilities with regard to delaying further action on the application of the Utility in the above referenced case. As stated in recent correspondence from me, the Utility and the Golf Course are currently involved in negotiations which involve the potential sale of the Utility and as long as that is proceeding at a pace satisfactory to K.W. Resort, we are in favor of the Commission delaying further action.

The Utility has recently received a letter of intent from the Golf Course concerning purchasing the system. As such, while the negotiations continue the matter is not resolved as yet. The Utility is in favor of the Commission further delaying action on this case while those negotiations continue at a reasonable pace. Therefore, K.W. Resort Utilities hereby proposes that the Commission delay any further action on this proceeding for three months from today's date. If and when any additional events occur in this negotiation which indicate that the settlement negotiations have broken down or are finalized, we will immediately report to the Commission on those matters.
