CASE BACKGROUND

In Order No. PSC-97-0629-FOF-TX (Docket No. 970207-TX), the Commission granted Alternative Local Exchange Certificate No. 4861 to Supra Telecommunications & Information Systems (STIS) effective July 21, 1997, based upon the company's assertion in its application for certification that it had sufficient technical, financial and managerial capabilities to provide service.

On September 3, 1997, the Division of Consumer Affairs (CAF) received two consumer complaints concerning unauthorized switching of local telecommunications service. Commission staff and DOCUMENT SUMPER-DATE

officials of STIS met in Tallahassee on October 21, 1997, to address the slamming complaints, which then numbered 63. They addressed misleading solicitation by STIS and lack of responses to Commission staff inquiries. STIS assured staff that it would take corrective action immediately. Nevertheless, staff believes this recommendation is necessary in view of the large number of complaints and the company's apparent inability to manage its telemarketers.

As of November 24, CAF had received 139 complaints concerning unauthorized local telecommunications service switching by STIS. (Attachment A, Pages 6, 7, 8 and 9)

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission order Supra Telecommunications & Information Systems to show cause in writing within 20 days of the issuance of the order why it should not be fined \$278,000 for violation of Rule 25-24.820(1)(a), Florida Administrative Code, Revocation of a Certificate, for violation of the terms and conditions upon which the certificate was originally granted, and \$55,500 for violation of Rule 25-4.043, Florida Administrative Code, Response to Commission Staff Inquiries, or have its Certificate No. 4861 canceled?

RECOMMENDATION: Yes. If the fine is paid it will be forwarded to the Office of the Comptroller for deposit in the State of Florida General Revenue Fund pursuant to Section 364.285, Florida Statutes. (PRUITT)

STAFF ANALYSIS: Rule 25-4.043, Florida Administrative Code, requires a written response to a Commission staff inquiry within 15 days from the date of the inquiry. On October 22, 1997, STIS faxed a report to Commission staff in response to 63 unauthorized local exchange carrier complaints. (Attachment B, Pages 10, 11 and 12) Of the 63 inquiries issued to STIS as of the October 21, 1997, meeting with staff, the company had exceeded the 15 day response time for 37 of the inquiries.

Rule 25-24.820(1)(a), Florida Administrative Code, states:

 The Commission may on its own motion, after notice and opportunity for hearing, revoke a company's certificate for any of the following reasons: (a) Violation of a term or condition under which the authority was originally granted;

Rule 25-24.820(1)(a), Florida Administrative Code, allows the Commission to revoke a certificate for violation of a term or condition under which the authority was originally granted. STIS asserted in its application that it had adequate managerial expertise to operate as an ALEC. Based on staff's review of the complaints it does not appear that STIS has adequate managerial capability to operate as an ALEC. Customers reported to the Division of Consumer Affairs that they were misled into believing that they were speaking to representatives of BellSouth, not to an alternative local exchange company. For example, customers reported offers of a 10% discount for being good BellSouth customers. In other instances, they were advised that BellSouth would consolidate their bills, or that BellSouth was verifying their telephone numbers. There were also reports from customers that their local service was switched, even after they told the STIS telemarketer that they did not want their service changed. (Attachment C, Pages 13, 14 and 15)

By Section 364.285, Florida Statutes, the Commission is authorized to impose upon any entity subject to its jurisdiction a penalty of not more that \$25,000 for each day a violation continues, if such entity is found to have refused to comply with or to have willfully violated any lawful rule or order of the Commission, or any provision of Chapter 364. Utilities are charged knowledge of the Commission's rules and statutes. with Additionally, "[i]t is a common maxim, familiar to all minds, that 'ignorance of the law' will not excuse any person, either civilly or criminally." Bartow v. United States, 32 U.S. 404,411 (1833). Thus, any intentional act, such as STIS's conduct at issue here, would meet the standard for a "willful violation."

Staff believes that STIS's apparent conduct in switching local service without authorization and failing to timely respond to staff inquiries has been "willful" in the sense intended by Section 364.285, Florida Statutes. In Order No. 24306, issued April 1, 1991, in Docket No. 890216-TL titled <u>In re: Investigation Into The</u>

.

<u>Proper Application of Rule 25-14.003, Florida Administrative Code</u> <u>Relating To Tax Savings Refund for 1988 and 1989 For GTE Florida,</u> <u>Inc.</u>, having found that the company had not intended to violate the rule, the Commission nevertheless found it appropriate to order it to show cause why it should not be fined, stating that "In our view, willful implies intent to do an act, and this is distinct from intent to violate a rule."

Based on the number of consumer complaints the Commission has received in a three month period and the company's lack of timely responses, staff does not believe that STIS has adequate managerial capabilities to protect consumers from having their local service switched without authorization. Accordingly, staff believes there is sufficient cause to order STIS to show cause why it should not fined, or have its certificate canceled for the apparent be Rules 25-4.043 and violations of 25-24.820(1)(a), Florida Administrative Code. Pursuant to Section 364.285, Florida Statutes, STIS should be ordered to show cause in writing within 20 days of the order why it should not be fined in the amount of \$333,500, or have its certificate canceled. If the fine is paid, it will be forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund.

ISSUE 2: Should the Commission order all certificated local exchange companies (LECs) to discontinue providing local exchange telecommunications service to STIS, if Certificate No. 4861 is canceled?

RECOMMENDATION: Yes. Pursuant to Rule 25-24.805, Florida Administrative Code, the Commission should order all certificated local exchange companies to discontinue providing local exchange telecommunications service to STIS if the company's certificate is canceled at the conclusion of this show cause proceeding for unauthorized local carrier changes and failure to submit timely responses to Commission staff inguiries. (**PRUITT**)

STAFF ANALYSIS: Rule 25-24.805, Florida Administrative Code, states in part:

(1) No person shall provide alternative local exchange telecommunications service without first obtaining a certificate of public convenience and necessity from the Commission.

If STIS's certificate is canceled, any local exchange service offered by STIS would be in violation of Rule 25-24.805, Florida Administrative Code, and the Commission should order all certificated LECs to discontinue service to STIS.

ISSUE 3: Should this docket be closed?

<u>RECOMMENDATION</u>: No. This docket should remain open pending resolution of the show cause proceeding. (BOWMAN)

STAFF ANALYSIS: If the Commission approves Issue 1 or 2, this docket should remain open pending resolution of the show cause proceeding.


