PURPOSE AND EFFECT: The purpose of this change is to repeal a rule that is obsolete. It is not expected to have any effect. SUMMARY: The rule required the Commission to make a public interest determination before issuing certificates for the provision of shared tenant services and companies providing shared WATS service must be certificated. All rules for Shared Tenant Services are found in Chapter 25-24, Part XII, F.A.C. SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COST: Because the rule had no effect no SERC was necessary.

(3) The foregoing notwithstanding, until July 1, 1987, any person who is providing chared telephone service, is sharing telephone service or who has placed orders for shared telephone survice on or before November 4, 1985 may continue to receive that service. Persons affected by this rule shall be notified by the local exchange companies of the content of the rule within 30 days from the effective date of this rule.
