By this letter, the Commission staff requests that Sanlando Utilities Corporation (Sanlando or utility) provide responses to the following data requests.

- 1. The rates proposed in the utility's application represent two scenarios; first, when there are no reuse customers, and second, when they are four reuse customers. However, on page 1 of the utility's customer notice it states "as reuse irrigation customers become available the utility will commensurately reduce the additional rates being charged the wastewater customers until they fall to the lower proposed rate."
- ACK _____ (a) Is it the utility's intention to lower the wastewater rates separately each time a new reuse customer connects?
- CAF _____ (b) If yes, since there could potentially be four separate wastewater rate reductions CMU _____ before reaching the lowest proposed rate, please explain how the utility proposes to implement the rate reductions (i.e., when will proposed tariffs be submitted, how will customers be notified of the rate reduction, etc.)
 - (c) In the event the utility is able to serve more than the four known potential reuse customers, does the utility propose to apply the same rate reduction methodology when additional reuse customers are connected?

- 5. Please provide all correspondence between the Company and any lending institutions concerning the terms and conditions under which the Company could borrow money to finance the capital cost of the reuse project.
- 6. Please identify all lending institutions that the Company has contacted either in writing or verbally concerning the possibility of financing the capital cost of the reuse project. For each lending institution, please explain what information was given to the lending institution and what the response of the institution was.
- 7. For purposes of this request, please refer to the Company's response to Staff Interrogatory No. 26.
 - (a) Is there an interest coverage requirement associated with the Company's existing debt?
 - (b) If the response to (a) is affirmative, what is the interest coverage requirement?
 - (c) If the response to (a) is affirmative, please provide a copy of the document which sets forth this interest coverage requirement.
- 8. For purposes of this request, please refer to revised Exhibit A, Schedule 5. Please provide the source of the 474,500,000 gallons of reuse depicted on this schedule.
