Dear Mr. Moses:

Pursuant to our conversation, please accept this letter as a formal request by Davel Communications Group, Inc. to change the name on the existing IXC/AOS certificate from Tel leasing Enterprises, Inc. to DavelTel, Inc. Enclosed is a certificate from the Florida Secretary of State verifying that DavelTel, Inc. was qualified to do business in Florida on July 23, 1991. The certificate further states that DavelTel, Inc. is in good standing as a Florida corporation as of February 13, 1998. Also enclosed is a copy of the Certificate of Public Convenience and Necessity which is the subject of the name change request.

This request for a name change is administrative in nature and no change of control will result. Both Tel leasing Enterprises, Inc. and DavelTel, Inc. are currently and will remain wholly-owned subsidiaries of Davel Communications Group, Inc. The purpose for the name change is to enable Tel leasing Enterprises, Inc. to maintain existing payphone certifications and operations, while DavelTel, Inc. will maintain interexchange carrier and operator services certifications and operations. All other information related to the current IXC/AOS certification remains unchanged.

Based on our prior discussions, my understanding is that there are no formal requirements to complete the name change other than sending this letter request and a copy of the accompanying Secretary of State certificate to verify DavelTel, Inc.'s corporate existence and status in Florida. Please advise me immediately if this understanding is incorrect.

We would appreciate an official acknowledgment from the Commission sent to the record address once the name change has been completed.
