CONTINUATION OF PROCEEDINGS 1 WHEREUPON: 2 ALFRED BYRD, 3 being first duly sworn by the Hearing Officer, was 4 examined and testified under oath as follows: 5 THE WITNESS: Yes. 6 THE COURT: Go ahead, counsel. 7 MS. COWDERY: Okay. 8 DIRECT EXAMINATION 9 BY MS. COWDERY: 10 Q Mr. Byrd, for the record, would you please 11 give your name and address. 12 A Alfred Byrd, Post Office Box 134, Apartment 13 14 96. THE COURT: What city? 15 THE WITNESS: Sanford, Florida, 32772. 16 17 BY MS. COWDERY: Mr. Byrd, were you a partner with a Mother's 18 Q Kitchen Restaurant, Mother's Kitchen Limited? 19 Yes. Α 20 Do you have any independent recollection 21 Q about turning on the gas service at Florida Public 22 23 Utilities Company? Yes. 24 A Does this come from your own recollection? 25 Q

I didn't quite understand you. 1 A Is this something that you are remembering 2 0 yourself, you're sure you went down there and --3 Yeah, I went down there. When I was at the A 4 other hearing, I didn't remember at the time, but I 5 went to the office to be for sure that I was down 6 there, so the lady told me that I did pay that. 7 Q But, do you remember going down there 8 without talking to anybody? 9 I didn't talk to anybody, as far as I know. A 10 I went down there and paid the bill for the gas to be 11 12 turned on. All right. Do you have a memory of any of 13 0 the details, what happened when you went down there? 14 I don't. I really don't. 15 A No, ma'am. Why did you leave Mother's Kitchen? 16 0 Well, the reason I left, when we first 17 A started, they paid me \$350 a month -- I mean, a week. 18 I stayed there about four months. After them many 19 weeks, I didn't make anything. So, I left. 20 I wasn't making any money. My bills were 21 behind. Everything was behind. I had to borrow money 22 to go pay my rent. I had to get money to go pay to get 23 a haircut. So, I had to go. I couldn't -- I couldn't 24 stay there when I wasn't making anything. 25

Okay. 1 Q What was the deal with the money, I don't 2 A 3 know. I can't tell you. Because I didn't have no 4 money. Now, you had a deposition and at your 5 0 deposition, one of the papers that you brought with you 6 -- did you bring with you when you came to your 7 8 deposition, any calendar pages? Yeah. I brought all of my papers here. 9 A I've got them here. All the papers I have. 10 0 Hang on. Is this one of the pages that you 11 brought with you today, this calendar page? 12 Yes, I'm sure I brought this, too, because I A 13 got it all in this here. 14 Did you prepare that? Did you write on that 0 15 document? 16 I probably did. I probably did write on 17 A this. 18 Do you see on --19 0 MS. COWDERY: I'm going to have this marked 20 21 for identification. MR. BROOKS: Your Honor, I object. He's 22 stating he probably did. There's no -- there was 23 hesitancy at the recognition of the thing and 24 there's no -- she gave no other basis for entering 25

11	BY MS. COWDERY:
12	Q Mr. Byrd, do you have with you your original
13	document that matches this document I have a copy of?
14	A Yes.
15	Q Do you have a copy of that?
16	A Yes, I'm sure I have it in this pouch here.
17	Q Do you want to check and see and look at
18	your original document?
19	A (Witness complies.)
20	Q Did you bring those documents with you today
21	under subpoena?
22	A Yes. This is the one here (indicating).
23	Q Did you prepare that? Did you write
24	anything on that document?
25	A Yes.

Are you sure? 1 A I'm sure. 2 All right. What did you write on that 3 Q 4 document? Well, I wrote that -- I was getting my 5 A social security check, so I wrote that date down and 6 the day that I left there was on the 29th. 7 Okay. When you say, the day that I left 8 0 there, what does that mean? 9 A The day that I walked out. 10 Of where? 0 11 A Of Mother's Kitchen. 12 Q Do you mean to say that's the last day you 13 worked there? 14 That's the last day. That's the last day I 15 А worked there. 16 Now, why did you write it down on the 17 0 calendar? 18 A Because I wanted to remember, because that's 19 the only way I -- I didn't have another book or 20 anything, so I just wrote on the calendar. 21 Did you at any time use that document for 22 0 any purpose? Did you bring it anywhere? 23 I always kept it with me. That was all. A 24 25 At any point were you -- did you have to go Q

A Yes. They give it to me -- it was sent to 11 me in my mail, \$39,000, and I never made that kind of 12 money in a whole year, as I remember. 13 So, did you bring that document at that time 14 0 to the IRS with you? 15 Yes. I went there in Maitland. We went 16 А 17 there. So, you did not prepare this document for 18 0 anything having to do with this case? 19 A No. 20 21 0 You already had that? I already had that, yes. 22 A MS. COWDERY: Thank you very much. I would 23 like to have that entered as an exhibit in the 24 record. 25

BROOKS: No objection, Your Honor. 12 THE COURT: Without objection, what had been 13 marked for identification as Respondent's Exhibit 14 B, is admitted in evidence as -- it will be 3, 15 Respondent's 3. 16 (Respondent's Exhibit 3 was admitted in 17 evidence.) 18 BY MS. COWDERY: 19 Mr. Byrd, during the time period that you 20 Q were employed at Mother's Kitchen or that you worked at 21 Mother's Kitchen, --22 23 A Yes. -- did you ever sign a check to pay a gas 24 0 bill? 25

I cut -- I don't -- to tell you the truth, 1 2 it's been so long, I don't remember exactly what day did I sign a check. I think they gave me a check. I 3 went down and paid the bill, because I went down -- I 4 forgot the time that I went, but I went to the lady in 5 the office there and asked her, did I come down and pay 6 7 that check, because the last time we was at the hearing I didn't know. 8 But, I went there to the office to be for 9 10 sure that I paid that check, paid that amount of money. So she said, yeah. And I said, well, that's good. 11 MS. COWDERY: Well, Mr. Byrd, I have a copy 12 of the check. I'd like to have this marked for 13 identification. It's Mother's Kitchen check 14 number 1131 in the amount of \$211.72, both the 15 front and the back. This is the best copy that we 16 17 can make. THE COURT: I'll mark it for identification 18 as Respondent's Exhibit C. 19 (Respondent's Exhibit C was marked for 20 identification.) 21 BY MS. COWDERY: 22 Is that your signature on the check, sir? 23 0 Yes. 24 А To the best of your recollection, would that 25

be the check that you signed in order to pay \$211.72 to 1 Florida Public Gas Company? 2 Yes. 3 A MS. COWDERY: I'd like to have that entered 4 as an exhibit. 5 THE COURT: Any objection? 6 7 MR. BROOKS: Yes, sir. I sure do. Mr. Byrd stated in response to Ms. Cowdery's answers that 8 he was down there and a lady -- his own 9 recollection concerning this particular item was 10 that he went down there and some mysterious lady 11 told him that he did this check. 12 Now, if Mr. Byrd did this check, Mr. Byrd's 13 14 recollection should be of doing this check and since he's not giving -- he's not giving that 15 positive response in regards to this check, I 16 would object to it being entered into the record 17 as an evidentiary exhibit, because she has not 18 laid a proper predicate for it to be entered. 19 THE COURT: Respond? 20 MS. COWDERY: I think Mr. Byrd has 21 identified that that's his signature on the check. 22 THE COURT: He did. 23 MS. COWDERY: And he said, to the best of 24 his recollection, that that's that check he wrote 25

and I don't know what else there is to do than 1 2 that. MR. BROOKS: Mr. Byrd is saying, I believe. 3 THE COURT: It's a check he wrote, but it 4 didn't refresh his memory as to whether he paid 5 it. So, I mean, if it's only offered for the 6 purpose that it's a check he wrote with a date of 7 8 July 24th, '96, --9 MS. COWDERY: Okay. THE COURT: -- I'll admit it for that 10 11 purpose. MS. COWDERY: I need it to establish that on 12 July 24th, 1996, he was still employed by the 13 company and working at the company and I think 14 this goes to show that on that date, he was 15 writing the check to pay a bill for Mother's 16 Kitchen. So, for that purpose, I will enter it. 17 If he doesn't remember anything else, he doesn't. 18 THE COURT: All right. As far as his 19 testimony as far as whether he paid it or not, 20 you're right, I haven't heard enough that says he 21 remembered. 22 MS. COWDERY: All right. 23 THE COURT: But, did you have any objection 24 that this is an authentic copy of a check drawn 25

7	THE COURT: I mean, what happened to it, I
8	don't know yet. It hasn't been established, but
9	the document itself is admitted in evidence as
10	Respondent's Exhibit 4.
11	(Respondent's Exhibit 4 was admitted in
12	evidence.)
13	BY MS. COWDERY:
14	Q Mr. Byrd, where did the name Mother's
15	Kitchen Restaurant come from?
16	A Well, the name of Mother's Kitchen, when I
17	lived in New York, we meant Mrs. Bell's in Jersey and
18	we purchased that place, but she already had that name,
19	Mother's Kitchen. So, we just continued, carried the
20	name, after I lost everything, the house, the business
21	and everything.
22	Then we just continued to carry that name
23	and then we got together and decided we would use that
24	same name, and that's where it came from, Mother Bell.
25	I call it Mother Bell.

Did you previously own a restaurant for a 1 number of years in Sanford that was called --2 A For 17-and-a-half years I owned Mother's 3 4 Kitchen on 13th Street. So, you had established that name? 5 Q I had established that name, yes. 6 A 7 You still work as a cook, do you not? Q Yes, I still work as a cook. 8 A Where are you working right now? 9 0 At the Marina Hotel where the Holiday Inn 10 A used to be on the waterfront. I'm still a chef. I 11 work with a chef now, I'm not a chef there, but I work 12 with a chef. 13 So, you were bringing your expertise into 14 0 the business, is that right? 15 Yes. 16 A Now, when you had -- strike that. 17 0 Did you set up or did anyone else in 18 19 Mother's Kitchen set up any other utilities or banks or 20 any other things like that in --21 A Like what now? I'll start over. 22 0 When you were part of Mother's Kitchen, was 23 any other creditor account set up in the name of Alfred 24 Byrd, doing business as Mother's Kitchen? 25

Not as I remember, was credit cards served 1 A in my name. No, I don't. I don't remember that. 2 Not credit cards. Like let me show you a 3 0 document and I'll show you what I mean. 4 The Seminole National Bank account, do you 5 recall anything about a Seminole National Bank account 6 being set up for Mother's Kitchen? 7 A checking account. This is it here. Mr. 8 A Brooks and I went and set that up and no one could sign 9 a check but he and I. So, when after this was done 10 afterwards, I left the place, the restaurant, I went 11 and paid -- because some checks were written in my name 12 and signed and I didn't even know anything about it. 13 So, I went to the bank. They charged me \$26 14 and some change, I just remember the amount, and here 15 is the ones that I -- this is the bills that I closed 16 that checking account out after I left there. 17 What was the date that you closed out the 18 0 Mother's Kitchen checking account? 19 It was 8/7. 20 А 21 0 Of what year? Of '96. Α 22 So that's 8/7 of '96? 23 0 Right. I closed the checking account out 24 А and it cost me \$26 and some change. 25

Now, do you remember whether or not the Bell 1 South bills were set up so that they would go to your 2 P.O. Box? 3 A Yes. 4 Was there an amount owed to Bell South by 5 0 Mother's Kitchen? 6 After I left Mother's Kitchen, they 7 A continued running Mother's Kitchen and they sent me a 8 9 bill for over \$1,000 and I wasn't even there. Did you call Mr. Brooks about that bill? 10 0 No, I didn't call him. I didn't contact 11 A them at all about anything. 12 So, did you just pay it or what was --13 0 No, I haven't paid it. They sent me a bill 14 A and just the establishment continued to keep running, 15 but I wasn't there. So, they ran it up to \$1,000, over 16 \$1,000. I got the bill, I guess, here. 17 So, they sent me a what you call it, a 18 credit thing, that it would be in the credit whatever 19 and then I would have to pay it, but I haven't had 20 money to pay that kind of a light bill, because I 21 didn't run the light bill up. Although it was in my 22 name, but I wasn't there in the establishment. 23 Now, Mr. Brooks (sic), the deposition we had 24 0 back in December of 1997, do you remember stating that 25

you had talked to Mr. Brooks about paying those? Do 1 you remember that at all? 2 I never spoke to him about that, after I got A 3 that bill. I never said anything to him. I asked them to take my name off. 8 But, I don't know why they didn't take my name off. 9 All right. Mr. Brooks (sic), I'm going to 10 0 just read to you from your deposition on page 46 and 11 starting with line four. Well, let's start with line 12 11. talking about Bell South bills, it's sort of in the 13 middle of a conversation. 14 So, question, "Okay. Just as other Bell 15 South bills did?" Twelve, answer, "Just as other Bell 16 South Bills" -- I'm sorry. Let me start up with line 17 eight. 18 Okay. Answer, "So I opened the letter and 19 that's what it was. I didn't open it just to find out 20 what it was. I opened the letter because it came to my 21 box." 22 Eleven, question, "Okay. Just as other Bell 23 South bills did?" Line 12, answer, "Just as other Bell 24 South Bills." 25

Question, "What did you do with those other 1 bills?" Answer, "I don't know. I'd have to go through 2 the house. I couldn't tell you whereabouts." 3 Question, "Okay. Did you pay them? Did you 4 give them to Mr. Brooks to pay?" Answer, "No, I didn't 5 6 give them to him to pay." Question, "Why not?" Answer, "Because when 7 I called him recently at 300, I think 300-and-some-odd 8 dollars still got to be paid here and I haven't had the 9 10 money to pay." Question, "Okay." Answer, "But I called 11 them, a couple of them recently called and talked with 12 them, but he told me, well, you got to pay them, you 13 know." 14 Do you remember that or you just don't 15 remember? 16 I really don't remember calling them and 17 A telling them about bills that I got from that, from 18 that telephone. I mean, from the lights or the 19 telephone. I never -- I don't -- because I never 20 contacted them anymore after this. 21 Okay. That's fine, sir. 22 0 I never did contact them anymore. А 23 Okay. Mr. Brooks, do you remember whether 24 Q or not Florida Power and Light was a creditor that had 25

an account set up in your name? 1 Yeah. It was in my name, yeah. 2 A Do you remember anything about who set up 3 0 that account, if you did it or if you did it with 4 anybody else or how it got set up? 5 What I did, I borrowed \$1,000 and we set 6 A that up. Mr. Brooks, I'm sure he helped me do that. 7 He helped me and showed me how. We set it up for their 8 account and that's all -- you know, then from there on 9 we went on from there. 10 So, did you feel like you were a part of 11 0 getting the business going? 12 A Yes, I feel like I was a part of it, which I 13 was. I didn't feel like it, I knew I was. 14 So having an account set up in your name was 0 15 16 not a surprising thing to you? In that it wasn't, because my name was on 17 Α everything, it seemed like. My name was on everything 18 and I didn't know. 19 I mean, I'm working and trying to work with 20 the business and knowing that my name -- I didn't know 21 my name was on -- say my name was on everything, and 22 then when I knew anything, after I left, then 23 everything just came right on me like this, bam. 24 MS. COWDERY: Okay. I have no further 25

5	BY MR. BROOKS:
6	Q Mr. Byrd, do you recall having a
7	conversation with Eddie Hodges, Arthur Brooks and
8	myself in front of my mother's house in February or
9	March of '96?
10	A I don't exact I don't exact remember the
11	date, but we probably did. I know we had a few
12	meetings together, but I don't remember exact dates.
13	Q Do you recall such a meeting where we were
14	discussing coming up with monies to pay utilities, the
15	rent, the security deposits for the rent, that type of
16	thing?
17	A I remember something like that. Yes, we
18	did. We talked about that.
19	Q During the conversations that you can
20	remember when we had to when we had to put together
21	these sums of money, did you contribute any money to
22	those?
23	A No, I didn't have anything to contribute.
24	Q Why did you not have any funds to
25	contribute, Mr. Byrd?

I just didn't have any. But you knew that I 1 didn't have any. You knew that I had no money. 2 Mr. Byrd, in December and January of 1997 --3 Q '96, I'm sorry. December '95, January '96, is it not 4 true that the IRS was about to put you in jail? 5 MS. COWDERY: Objection. 6 THE WITNESS: Well, that -- but that wasn't 7 in Mother's Kitchen as to your place. 8 THE COURT: Wait. Just a moment. There's 9 an objection. Don't answer until I rule. 10 THE WITNESS: All right. Sorry. 11 THE COURT: Yes? 12 MS. COWDERY: I'm objecting as to being 13 outside the scope of direct. Any questions which 14 I had which were relating to IRS were just for the 15 purposes of asking, were these documents prepared 16 at a previous time, not the substance of why he 17 went to the IRS. It goas to timing. That's 18 something that the substance was outside the scope 19 of direct. 20 THE COURT: Where are you trying to go with 21 this? 22 MR. BROOKS: Sir, Ms. Cowdery's questions 23 concerning the IRS and Mr. Byrd go a lot further 24 than any trying to establish a document. She 25

All of these things lead to -- lead to an attempted -- an attempted showing that some wrongdoing was done by the rest of the partnership towards Mr. Byrd and my question goes to Mr. Byrd's credibility. I have, I believe, --

THE COURT: Okay. That's fine. I'm going to overrule the objection. You opened the door. You may answer the question.

THE WITNESS: On that particular time, my wife and I, if you want to go back, we borrowed, I think, about \$60,000 with interest and everything, because the IRS said that we owed them some money. This is before I really dealt with Tony, any of those people at all. I didn't even know them that well.

So what happened, the fellah that fixed my 18 19 papers, he took the money after 10 days, so they foreclosed on my home and the restaurant. So, I 20 had to get out the best I could. I had to get on 21 the best I could. I couldn't do nothing else. 22 But, it wasn't involved with them. It was 23 involved with my wife and that's when she was 24 alive. 25

So when he filed, the IRS told them to file 1 the file and get out from under that. He filed, 2 but he kept the money. So, that's what happened 3 on that standpoint. BROOKS: 8 Mr. Byrd, did not you and I contact the IRS 9 0 and the US Marshall's Office to prevent you from going 10 to jail? 11 Yes, you did. 12 A Did not I prepare your backdated taxes to 13 prevent you from owing the IRS anything? 14 15 A Yes. So, our relationship was more personal than 16 0 what you said. You were saying you didn't know me --17 It was more personal --18 A -- you didn't know me that well. 19 0 No, I didn't know you that well to the 20 A extent of partnership, but as a businessman I figured 21 that, you know, I knew you that way. Because when all 22 this happened, my wife had died at that particular 23 time. 24 Mr. Byrd, how long have you known me? About 25 0

how long have you known me? 1 I've known of you for guite a few years, but 2 A to know you, I didn't know you until we got in the 3 business. 4 5 As a business partner, I didn't know you, 6 but I knew you as a person, as a way I thought we was pretty good friends, which I'm not mad with you now. 7 But as a friend, yes, but as a businessman, no, I 8 didn't know you. 9 Q When you needed help with those things, did 10 I seek you out or did you seek me out? 11 Well, I know I told you about this and then 12 A 13 you started working with me on that particular part of the business on that IRS, but I don't see where the IRS 14 has got anything to do with Mother's Kitchen over on 15 Airport Boulevard. 16 Mr. Byrd, did not myself and Daniele loan 17 0 you \$2,500 to purchase an automobile? 18 I paid you back, too. Yes. 19 Α 20 But did we not do that? 0 21 A Yes, definitely. I'm not denying that. All right, Mr. Byrd. Now, you stated that 22 0 at the time we were considering opening up this 23 24 business, you didn't contribute anything because you didn't have any funds. 25

15	registered to you?
16	A Yes.
17	Q And what did we find out?
18	A It wasn't registered to me, as I remember.
19	Q Now, Mr. Byrd, during those times in
20	obtaining those licenses with county services, the
21	city, with the state and I'm sorry, the State DOR,
22	all of these particular places, who went and paid for
23	those licenses?
24	A You took care of it.
25	Q When it came to the \$200 to take to the gas
100	

company, who supplied the \$200 to take to the gas 1 company for the deposit? 2 If I'm not mistaken, that \$200 came from 3 A that \$1,000 that I borrowed. 4 Mr. Byrd, you just testified, under oath I 5 0 might add, that March 17th, 18th and 19th, we went and 6 obtained licenses. You testified under oath that you 7 had no funds to provide for that. 8 The money that we borrowed, the \$1,000, I 9 A didn't say I didn't have no -- I didn t have that --10 all the money I had was the time we borrowed, I 11 borrowed \$1,000 from General Loan Company to pay for 12 the lights and, if I'm not mistaken, like I said, if 13 I'm not mistaken, I took \$200 from that and we went and 14 paid for the gas. 15 Q Do you know when you borrowed the money from 16 American General ---17 No, but I got all the papers at the house. 18 Α I don't remember the date that I borrowed it. 19 MR. BROOKS: Might I approach, Your Honor? 20 THE COURT: Yes. 21 BY MR. BROOKS: 22 We have here what's been entered as 23 0 Petitioner's 1, Mr. Byrd. 24 25 A Okay.

21	I only had money when I borrowed the \$1,000
22	to turn the lights on and whatever little bit I had
23	left there, we used it, but I don't know exactly what
24	we used it for.
25	Q Mr. Byrd, when you went in and made

1	application for this loan at American General Finance,
2	who took you there?
3	A You went with me.
4	Q Who went into the building with you?
5	A You.
6	Q Mr. Byrd, is it not true that Don Mealey
7	Chevrolet was hounding you about a \$550 check, returned
8	check from your personal account that was utilized to
9	pay for damage done to your car at that time?
10	A Yes.
11	Q Was it not true that there were private
12	investigators threatening action against you if that
13	check was not taken care of?
14	A I if I'm not I don't remember them was
15	at me or nothing, but I knew that they had called me,
16	because they did send me a letter about that check.
17	Q Were you not also, at that time, behind in
18	payments to Friedman's Jewelers?
19	A Yes.
20	Q Now, is it not true that when the time that
21	this loan was obtained, that you had been asking me
22	about or, I'm sorry. Strike that.
23	Is it not true at the time that this loan,
24	this particular loan was obtained, that you had been
25	discussing with me the need to get monies to take care

of some of those pressing deals? 1 That's right. 2 A Is it not true that when we went into 3 0 American General Finance and this loan was obtained for 4 you, is it not true that the monies from this loan went 5 to pay Friedman's Jewelers, pay Don Mealey Chevrolet 6 and you contributed \$330 of the remainder, you 7 contributed \$330 towards the deposit for the Florida 8 Power and Light Company? 9 No, that wasn't so. I did not pay Don 10 А Mealey any money out of that \$1,000. I paid 600 and I 11 just remember the money that I paid for the light bill 12 to be paid on at Mother's Kitchen, over \$600. 13 You paid over \$600 --0 14 That's right. 15 A -- for the lights to be turned on --16 0 For the deposit for the lights to be turned 17 A on. But, I did not pay Don Mealey one dime out of that 18 \$1,000. 19 You didn't pay Friedman's? 20 0 No, I didn't. I don't remember -- I'm sure, 21 A I was paying -- I get a social security check so I'd 22 take and do my best with whatever I'd get from my 23 social security check and pay my small bills. 24 Mr. Byrd, was there ever a check made out to 0 25

Friedman's Jewelers from the Mother's Kitchen account? 1 I never seen it. I don't even have the 2 A check. 3 MS. COWDERY: I'm going to object at this 4 point, because you get to a certain point in what 5 I see as being irrelevant, where I think it does 6 7 get to be prejudicial as confusing the issues and bringing in unnecessary information to the issues 8 of the case and that's how I see it. I don't see 9 the source of any funds as having any direct 10 11 bearing on how an account is set up with the gas 12 company. MR. BROOKS: Sir, what we have here is Ms. 13 Cowdery and her clients maintaining that the 14 account was intentionally set up in the name of 15 Alfred Byrd, doing business as Mother's Kitchen. 16 She even went to the point of coaching this man 17 prior to the opening of testimony here. 18 MS. COWDERY: Objection. 19 THE COURT: It goes to the phraseology. Go 20 ahead. 21 MR. BROOKS: She even -- concerning his 22 testimony towards that deposit. Mr. Byrd has sat 23 there and repeatedly, repeatedly, to questions 24 concerning this particular deposit as well as 25

Now, for the Respondent -- for the Petitioner, the Petitioner's only option is to show that there was no way that this could have happened other than the way that the Petitioner has put forth here.

If he is going to sit here and testify about what they told him, what they told him happened, so he's making the wholesale assumption that everything the Respondent says is true. So, our right to go to credibility here, even to the point of a payment to another place that he is now denying that this money -- I went with this man to get this money -- that this money went to, then Petitioner has a right to show that that place where the monies actually went exists and not only did he use this money to pay it, but he also used money from the company to pay it.

THE COURT: I appreciate where you're trying to go and I think as far as credibility is concerned, that you've elicited some testimony there. But, to continue further out it's just too far afield and I think we've gotten to the outer limits. So, I'll sustain the objection.

MR. BROOKS: Is it eight? 1 MS. COWDERY: I think it's seven. 2 THE COURT: The last exhibit I have is the 3 receipts --4 MR. BROOKS: Yes. Yes, sir. Yes, sir. 5 6 Sorry. THE COURT: Okay. Without objection, the 7 document's admitted in evidence as Petitioner's 8 Exhibit 7. 9 (Petitioner's Exhibit 7 was admitted in 10 evidence.) 11 BY MR. BROOKS: 12 Ms. Keitt, on the 13th of September, 1996, 13 0 you -- is it your recollection that the serviceman at 14 Mother's Kitchen told you over the phone that there was 15 a leak there at the restaurant? 16 I don't remember whether it was over the 17 A phone or on the radio. 18 Ms. Keitt, you stated that on -- with 19 0 regards to your testimony you centered around August 20 12th, one of the things that was brought up was I was 21 supposed to have told you to change the address on the 22 account? 23 A That's correct. 24 O Ms. Keitt, can you explain to me why your 25

That's my signature. 1 Did you prepare this document? 2 Q 3 A Yes, I did. Now, do you know who ordered and signed that 0 4 work order? 5 A Mr. Byrd signed it. Who ordered it, I -- I 6 wouldn't know who ordered it. 7 0 Do you recall if he signed it in your 8 presence? 9 Yes, he did. 10 Α What work did you do on June 3rd? 11 0 When I arrived there, the pilot oven was out 12 Α and they could not keep it lit. So, I decided that the 13 pilot was dirty, it needed cleaning. I cleaned the 14 pilot. I lit and cycled the appliance and made sure 15 that it worked properly. 16 Was this a new oven or a used oven? 0 17 A This is a used oven. 18 Just in very general terms, can you give an 19 0 estimate about how old, very general? 20 I'd say 15 to 20 years old. 21 Α Now, is this the same oven that you worked 22 Q on at Mother's Kitchen in September? 23 A Yes, it is. 24 MS. Is that the meter that's in place or do you 8 0 bring something? 9 That is the meter that is in place on some A 10 accounts. 11 What about Mother's Kitchen? 12 0 At this account there was a guarter-foot 13 A dial and that's where the five-minute test is required. 14 Did you have to put anything on it, any Q 15 gadget? 16 No. 17 А You just looked at the meter? 0 18 Yes, ma'am. A 19 What did you do next? 20 Q I went in, I noticed there was a leak. I 21 A actually will mark it again to see if, you know, 22 something just might go wrong, but within another 23 minute it showed more consumption. So then, I proceed 24 to go inside to see if I could find it. 25

I think at the 6 А time, Mr. Brooks was the only one that really was in 7 probably my area. 8 Now, what did you do next? 9 0 I proceeded to look at the fryer and soap 10 A the gas connections, which were flexible connectors on 11 both of these units. 12 Did you say you started by looking at the 13 0 14 fryer? Yes, ma'am. 15 A Next I go to the flex connector, because 16 0 both of them are side by side. I remember soaping that 17 and in that time, you could get an odor of natural gas, 18 in which the account has. So, I --19 Was that on the oven or on the fryer? Q 20 21 А It was on the range then. All right. And then, what did you do next? 22 0 To where I thought it was -- I determined 23 А that I thought it was on the range and in the area that 24 I thought it was is a cover plate and the cover plate 25

It's a 9 A soap-type fluid that -- we mix it up and it's used to 10 detect --11 What did you find in this case? 0 12 I found on the pilot adjustment screw that 13 A goes to the safety valve, it was leaking out a screw. 14 There's a screw there. The adjustment screw had 15 bubbles coming out in that area. 16 Now, did you try to tighten the threads? 17 0 I did try to tighten it up, but this screw, 18 A if you do tighten it all the way, it's the type of 19 screw that will shut the gas off completely to the oven 20 21 safety. So, is there any way that you can fix this 0 22 problem by tightening the screw down? 23 This one, you would not. 24 A Because what would happen if you would 25

Now, at this point, had you made any 9 decision on whether or not you'd have to replace a part 10 or not replace a part? 11 A For the sloppiness and the tightness of the 12 screw, I would say that the part had to be replaced. 13 Why would that be? 14 Because screwing it all the way in, which it 15 A would not, even if you locked it in there, it was 16 bubbling. (A). TOOK MONEY DIRECTLY FROM MR. BROOKS FOR A BAD CHECK PRESENTED BY MR. BYRD AND DIRECTED MR. BROOKS FUNDS DIRECTLY TOWARDS THAT END. (B). TOOK MONEY DIRECTLY FROM MR. BROOKS AND HIS ASSOCIATES AND DIRECTED IT TOWARD MR. BYRD'S PAST DUE AMOUNTS.

BY DOING SO THE COMPANY ACKNOWLEDGED MOTHER'S KITCHEN RIGHT. TO THE ACCOUNT. OR IN THE ALTERNATIVE COMMITTED FRAUD BY TAKING MR. BROOKS AND ASSOCIATES MONEY AND ILLEGALLY PAID ANOTHER PERSON'S BILL WITH IT. (C). THE SERVICE WAS RESTORED.




