Dear Mr. Williams:

CoxCom, Inc. ("Cox") wishes to combine its two existing Florida AAV certificates under one ALEC certificate. Accordingly, Cox respectfully requests that the Commission convert Cox's two existing AAV certificates to ALEC certificates, pursuant to Section 364.337(6)(b), Florida Statutes (1997), and grant to Cox a single ALEC certificate covering Cox's two Florida operating systems.

Cox currently has the following Florida AAV certificates.


