Thank you for your letter filed with the Commission on April 2, 1998, in which you request that the application for an original certificate in the above-referenced docket be denied.

In an attempt to address some of your concerns, please note that Zellwood Station Co-Op, Inc., is a utility already in existence, operating without a certificate. Pursuant to Section 367.045, Florida Statutes, Zellwood must apply for a certificate of authorization from this Commission. The Commission has never had the opportunity to establish rates for this utility. We appreciate the information regarding the developer agreement and the attachment of the agreement regarding rates. However, pursuant to caselaw and Section 367.011, Florida Statutes, the Commission has exclusive jurisdiction over a utility with respect to authority, service, and rates.
