Re: Special Project No. 980000B-SP - Access by Telecommunications Companies to Customers in Multi-Tenant Environments.

By this time you should have received notice of the first staff workshop in the above-referenced special project. As stated in the notice, the purpose of this workshop will be to identify issues to be addressed in the Commission's report. In the interest of time and in order to conduct a more productive workshop on July 7, 1998, Commission staff requests that interested participants submit at their earliest convenience proposed issues associated with telecommunications companies serving customers in multi-tenant environments. At the August 12th workshop, participants will discuss their positions on the identified issues. Two weeks after the second workshop, participants will file any additional comments or rebuttal on information presented at the second workshop. Final comments will be received at the third workshop on September 15, 1998. We have also attached a schedule of critical dates for the project.
