### ORDER GRANTING IN PART AND DENYING IN PART FLORIDA POWER & LIGHT COMPANY'S REQUEST FOR CONFIDENTIAL CLASSIFICATION

On February 5, 1998, Florida Power & Light Company (FPL) requested confidential classification of certain material obtained during the Cost Allocation Between FPL and FPL Services Audit. The request was filed pursuant to Rule 25-22.006, F.A.C., and Section 366.093, Florida Statutes, and concerns Document Nos. 01333-98, 01334-98, 01335-98, 01336-98, 01337-98, 01338-98 and 01881-98. These materials comprised a portion of the staff's audit report and certain staff working papers.

On March 30, 1998, FPL filed a request for confidential classification of its response to the FPL and FPL Services Cost Allocation Audit Report, Document Nos. 03019-98 and 03672-98.

The materials for which confidential classification has been requested in the above-listed filings are characterized as 1) employee personnel information unrelated to compensation, duties, qualifications or responsibilities; 2) material related to or derived from internal audit reports; or 3) documents related to the company's and its affiliate's competitive interests.

Documents submitted to governmental agencies in Florida are public records. The only exceptions are the specific statutory exemptions provided in the law and exemptions granted by governmental agencies pursuant to the specific terms of a statutory provision. This is based on the concept that government should operate in the "sunshine".

Section 366.093(3), Florida Statutes, provides the following definition for proprietary confidential business information:

> The term proprietary confidential business information means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that disclosure of the information would cause harm to the ratepayers person's or company's or the business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public. The term includes, but is not limited to [inter alia]:

(b) Internal auditing controls and reports of internal auditors...

(e) Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information.

(f) Employee personnel information unrelated to compensation, duties, qualifications, or responsibilities.

As demonstrated by the charts in Attachments I and II, but with one exception, the material described above meets the requirements of Section 366.093(b), (e) or (f). Therefore, the information for which FPL seeks confidential classification is proprietary confidential business information pursuant to statute and may be accorded confidential classification as requested. The one exception concerns p. 15, lines 1-3 of Documents 03019-98 and 03672-98 (Attachment II). Confidentiality is denied as to that material, which concerns utility employee compensation, duties and responsibilities and is therefore excluded from confidential classification. Section 366.093(3)(f).

With that exception, pursuant to Section 366.093(4), Florida Statutes, the material in the above-listed documents shall be classified as proprietary confidential business information for a period of 18 months from the date of this order. prior to its expiration in accordance with Section 366.093(4), Florida Statutes.

Based upon the foregoing, it is

ORDERED by Commissioner Susan F. Clark, as Prehearing Officer, that Florida Power and Light Company's Request for Confidential Classification of Documents Nos. 01333-98, 01334-98, 01335-98, 01336-98, 01337-98, 01338-98 and 01881-98, as specified in Attachment I, is granted. It is further

ORDERED that Florida Power and Light Company's Request for Confidential Classification of Documents Nos. 03019-98 and 03672-98 as specified in Attachment II is granted with the exception of p. 15, lines 1-3 thereof, which is denied. It is further

ORDERED that pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, any confidentiality granted to the documents specified herein shall expire eighteen (18) months from the date of issuance of this Order in the absence of a renewed request for confidentiality pursuant to Section 366.093. It is further

ORDERED that this Order will be the only further notification by the Commission to the parties concerning the expiration of the confidentiality time period.

#### NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
