mailing address. Further, the disconnected line has been reconnected and a fax line added.

Further, even if a fine was the proper remedy for the alleged violation, (and we submit it was not) the fine of \$10,000 levied for the violation of Rule 25-4.043 is clearly excessive.

Likewise, the fine of \$500 for the violation of Rule 25-24.520, in light of the circumstance is also unwarranted and excessive.

Accordingly, Penn Boys requests a formal proceeding be initiated and an administrative hearing be scheduled. Considering the facts of this matter, Mediation may be helpful to resolve the issues without the necessity of the parties incurring the expense of formal proceedings and/or judicial review. If Mediation be granted, it is respectfully requested that it be held quickly. If possible, the Mediation should be held in the Miami area but if that is not possible, we would be willing to travel to whatever site is most convenient to the Mediator. I have spoken briefly with both Mr. Louis Yambow and Charles Pelligrini, Esq. Perhaps an informal mediation session with those persons or other Staff persons would result in as fruitful a session as a formal mediation with the neutral mediator. I am ready and willing to do whatever is reasonable and necessary to equitably resolve this matter.
