**TAMPA ELECTRIC COMPANY'S AMENDED
NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION**

Tampa Electric Company ("Tampa Electric" or "the company"), pursuant to Rule 25-22.006, Florida Administrative Code, hereby provides amended notice of its intent to request confidential classification of certain information contained in a limited number of documents to be produced by Tampa Electric in response to Staff's First Request for Production of Documents Nos. 1-35, and as grounds therefor, says:

1 On July 20, 1998 Tampa Electric served its Notice of Intent to Request Confidential Classification of certain documents to be produced in response to Staff's Requests for Production Nos. 5, 10 and 17, containing information the public disclosure of which will be harmful to the interests of Tampa Electric and its customers. Thereafter, the parties met on July 21, 1998 to discuss which of the various documents would actually need to be provided in order for Staff to prepare for this proceeding. Of the various confidential documents Staff identified a one-page confidential document included in the confidential documents responsive to Staff's Request for Production No. 17. Staff also identified 18 pages of documents contained in the company's response to Staff's Request for Production of Documents No. 10. All 19 pages


contain proprietary confidential business information the disclosure of which would be harmful to the company and its customers.

2 Rather than having the company turn the above-described documents over to Staff on July 21, Staff indicated that they would have ample time to use the documents in question if they were provided on July 30, 1998.

3 The purpose of this Amended Notice of Intent is to confirm that the above-referenced 19 pages of confidential documents are this date being delivered to the Division of Records and Reporting with the request that they be treated confidentially and made available only to the appropriate Staff members for review and preparation, and to reserve Tampa Electric's right to seek confidential classification of the documents in question within 21 days after these documents are delivered to the Division of Records and Reporting for review by Staff as described above (i.e., on or before Thursday, August 20, 1998).


