April, May, and June 1998

PROGRAM STATUS:

The FPL Green Pricing Research and Development Project (GPRDP) was approved by the Commission in Order No. PSC-97-FOF-0528-EG, dated May 7, 1997. This program is designed to allow FPL the flexibility to test FPL customer response to a Green Pricing Initiative. Under the GPRDP, FPL will solicit contributions from its customers to be used to purchase, install, maintain, and operate Photovoltaic (PV) modules on FPL's system.

Note: FPL has begun the education and solicitation campaign for the project.

ACTIVITIES CONDUCTED:

- FPL formalized involvement by the Florida Solar Energy Center to optimize the design of the actual photovoltaic facility and maximize the generation output for the level of funding received.
- FPL sent out inserts to large commercial and industrial customers in the May '98 edition of the FPL newsletter "Business Energy". These inserts are designed to educate commercial and industrial customers on the benefits of the project and solicit their participation.
- FPL mailed out bill inserts with the story of the "Solar Research Partnership" to all residential customers during the May billing cycle.
- Advertisements for the "Solar Research Partnership" were placed in major newspapers in Dade, Broward and Palm Beach counties.
