

**NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION  
OF SPRINT COMMUNICATIONS COMPANY LIMITED PARTNERSHIP**

COMES NOW, Sprint Communications Company Limited Partnership ("Sprint") and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. In accordance with the requirements of Section 364.163(6), Florida Statutes and Order No. PSC-98-0795-FOF-TP, Sprint filed its tariff implementing rate reductions effective July 1, 1998 and October 1, 1998.
2. The Order also required interexchange companies to submit documentation in support of the tariff.
3. Sprint considers the information contained in the supporting documentation to be proprietary confidential business information as defined in Section 364.183, Florida Statutes and Rule 25-22.006, Florida Administrative Code.
4. Because the supporting documentation contains proprietary information, Sprint is filing this Notice of Intent to Request Specified Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code. The Original of this notice has been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information.
