<u>Issue 2</u>: Is Florida Power & Light Company's calculation of the backbilled amount of \$15,451.79, including investigation charges of \$299.28, for the period March 19, 1991, to March 12, 1997, reasonable?

<u>Recommendation</u>: No. FPL should backbill Mr. Sadaka for the period March 17, 1993, through March 12, 1997, resulting in a charge of \$12,181.26 for unbilled energy. In addition, FPL should bill Mr. Sadaka for investigation charges of \$299.28 for a total amount of \$12,480.54.
